5. Staff Updates: L. Heine

- a. Executive Director: Lilea attended the first of three convenings of the First 5 Leadership Network Cohort 4, March 22-24. The next convening will be in June. There is also a funding update, Prop10 funding is declining at an accelerated rate due to the ban on the tobacco flavor ban (Prop 31). The First 5 Association is looking for sustainable pathways for funding. For now Lilea will be working with Commissioner J. Gallagher and Napa County to draft the budget for FY 23-24, which will be presented at the next commission meeting. Lilea is also looking to hire soon, hoping to develop roles that are flexible and able to evolve as the strategic plan is rolled out.
