A. Discussion and possible approval of \$5,000 expenditure to co-fund consultant fee to continue design team efforts to increase testing in the low income Latinx community (project of F5NN and County Public Health)

4. By Law Amendment, E. Gonzalez-Mares

A. #3 Officers; A. Chairperson and Vice-Chairperson; 2. Term: Strike the following sentence: "In no event shall the Chairperson or Vice-Chairperson serve more than two terms in that office."

a. Joelle reported that the Executive Committee discussed making a change to the bylaws in regards to Commission officers. Typically, a Chair and Vice Chair will serve for 2 years and then new officers will be voted in, with the Vice Chair becoming Chair. With the current COVID-19 situation affecting our Public Health representatives and their ability to attend meetings regularly, it would be helpful to keep current officers in place and revise the bylaw language for more flexibility now and in the future. The Commission agreed. Joelle will update the language and bring back to the Commission in December for review and approval.
